Exemption of additional information under The Freedom of Information Act 2000 - Section 31 - Law Enforcement

The Council will not disclose the deceased's full address details into the public domain. It is likely that the property is unoccupied and it might still contain the deceased's personal papers and effects. There are also concerns that criminal acts may be committed, for example fraud and theft. For these reasons the Council considers that there is no public interest in releasing the information requested. Any public interest is best served by upholding exemption 31 under the Act as disclosure of the information would be likely to prejudice the prevention of crime by enabling or encouraging the commission of offences.
