- Abstract: This collection contains burial permits and receipts for funeral (hearse, grave digging, etc) and cemetery (sales of lots, construction, maintenance, and Revolutionary War and War of 1812 markers) related expenses from 1816 1929. The Town of Westford has five historic cemeteries: the Fairview Cemetery, originally the East Burying Ground; the Westlawn Cemetery, originally the West Burying Ground; the Hillside Cemetery, originally the North Burying Ground; and Wright Cemetery. The finding aid includes a list of names mentioned in the documents to aid residents and others in genealogical research.

Biographical/Historical Note

Westford was first settled in 1635 and what is now the Town of Westford was originally part of Chelmsford as "West Chelmsford" and did not begin to develop until after King Philip's War. The Town of Westford was incorporated on September 23, 1729. It is bordered to the east by Chelmsford, to the north by Tyngsborough, to the west by Groton and Ayer, and to the south by Littleton and Acton. Westford is 23 miles northwest of Boston, 35 miles northeast of Worcester, 86 miles northeast of Springfield, and 220 miles from New York City.

The economy of Westford originally depended on subsistence agriculture and the grazing of cattle. In the late 18th and early 19th centuries, Westford primarily produced granite, apples, and worsted yarn and textile mills, orchards, and quarrying were developed and further contributed to the economy. More information about the history of the town and its cemeteries, including caretakers, can be found at the Town of Westford website.

Collection Scope and Content

This collection has been arranged into two series with one Hollinger box and multiple books. Folders have been arranged chronologically by document type, permits or receipts. Items are arranged in order they were found and unpacked. The receipts for the markers bought for the Revolutionary War and War of 1812 veterans are separated from the other material.

Series I: The Westford Cemetery Records 1816 – 1929, contains documents, written and typed, regarding the town cemeteries and burial permits. Document includes burial permits and disinterment permits; the bulk of the collection is Town Receipts for materials and labor for funeral and cemetery expenses. Those who received payments signed or made their mark upon receiving their money.

Series II: The Westford Cemetery Books and Bound Volumes 1835-2007, contains books and bound volumes containing records of sales of burial lots, lists of burials, burial permits, and burial permit stubs.

They had been stored in tin boxes in the old vault in the basement of the Town Hall since the vault was installed in the 1890s. These "Tin Box Records," as they are now termed, were recently moved to the town library where they were sorted, organized by year, wrapped in acid-free tissue, and placed in folders in an archival Hollinger box. They are now stored in the newly-renovated Town Hall in the new Town Clerk's special collections vault. The records described herein are those categorized as "Cemetery Records."
